

## SELECT BOARD MINUTES FOR APRIL 15, 2024

Meeting called to order at 6:31pm.

Nathan Lizak and Linda Fuerderer came in representing Kroka and introduced themselves to the Select Board, also enquired about tax exempt status and the possibility of entering a PILOT agreement with the Town. Select Board and Executive Administrator to do further research and will invite Kroka to be placed on the agenda once this has been completed.


A resident has expressed an interest in being Health Officer. John Luke will follow up with the resident.
